





Advanced Board Programme INSEAD is a unique board education that aims to develop the mindset and competencies of board chairmen and members.

The Advanced Board Programme gives you a unique opportunity to develop your board professional skills, while preparing you for the challenges of the future in a world that offers constant change, increased uncertainty and endless digital transformation initiatives.

To keep pace with developments, all of these upheavals require board chairmen and members to be able to reassess their roles, acquire new knowledge, and "unlearn" old habits and routines.

The programme offers a high degree of interactivity, and the participants' own experience and thoughts are an important part of the programme.

Board work in a global context

Advanced Board Programme builds on the Executive Board Programme INSEAD, and functions as a "superstructure" to this program. Among other things, you will deal with why the independence of the chairman and members of the board of directors is extremely important, and how you handle the factors that hinder this independence in your board function. The role of the board in an increasingly globalised world with many and rapid changes will also be part of the program, where, among other things, environmental, economic, social and political trends are on the agenda.



Digital expertise in board work

The programme also goes in depth into ways that comprehensive digital changes affect the work of the board, and what strategies a board should use, so that even at this level one manages to acquire digital expertise – and thus be at the forefront of rapid development. How to lead a board, how to handle the company's stakeholders and how you work with the CEO and executives are also topics that will be addressed. As chairman of the board, you must be able to balance the use of your authority with a facilitating role so that you are able to handle the dynamics of your board.

- **4.** Programmes must have a minimum total duration of 15 days
