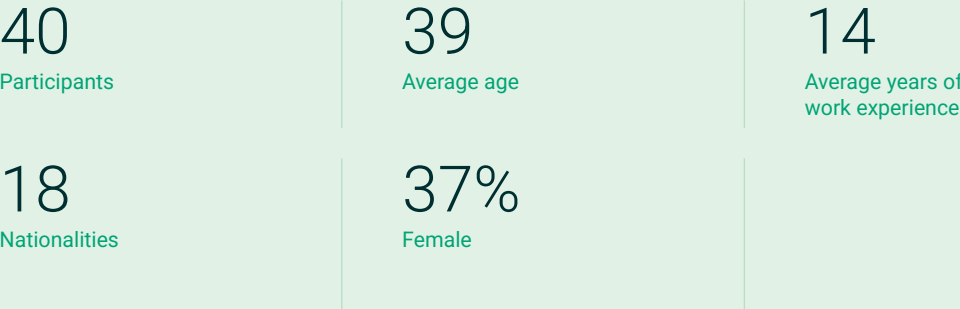

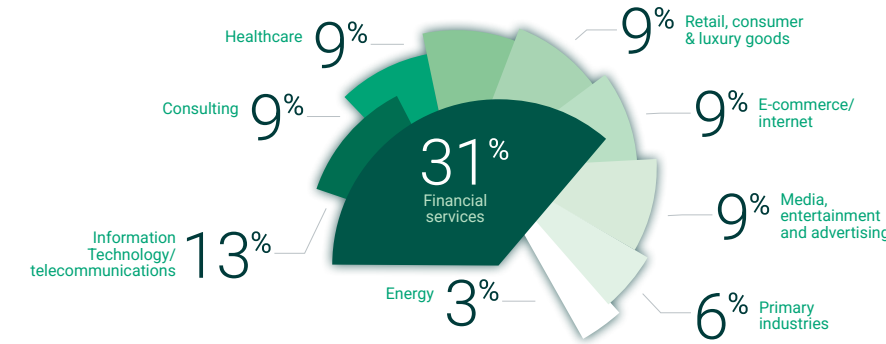

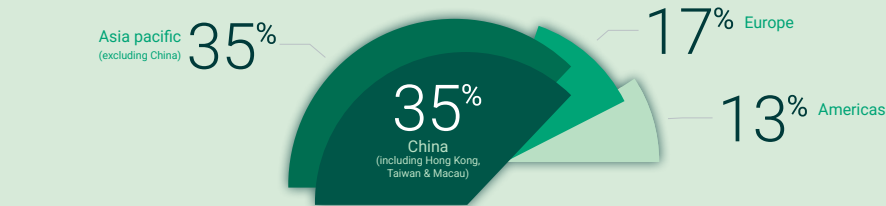
A typical TIEMBA class

Admissions

The following steps will guide you through your application process.

1. Pre-application assessment

Interested candidates are encouraged to send in their CV for a pre-application assessment by the recruitment team. You may email it to either tiemba@insead.edu (INSEAD Recruitment team) or tiemba@sem.tsinghua.edu.cn (Tsinghua Recruitment team).

2. Application process

The application process varies depending on your nationality.

For Chinese Nationals from Mainland China:

3. Complete and submit your application form

The following documents are required during application:

- Two letters of recommendation
- Colour copies of identity document
- Colour copies of degree(s) either in English or Chinese
- Original copies of official transcripts with grades from all universities attended
- A non-refundable application fee is required

4. Assessment options

All applicants must submit either a GMAT or GMAC Executive Assessment (EA) score, followed by an interview. Alternatively, they may opt to complete an in-house admissions test.

Non-Chinese nationals can choose between the INSEAD Executive Test or the Tsinghua TIEMBA Assessment. Chinese nationals hailing from Mainland China, Hong Kong, Macau, and Taiwan are obliged to take the Tsinghua TIEMBA Assessment.

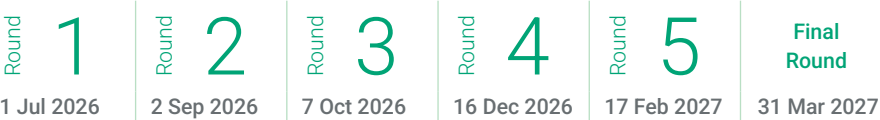
Additional information

Chinese Nationals from Mainland China who wish to enroll in an EMBA programme are required by the Ministry of Education, China, to take the National Entrance Exam. You will have to obtain a Conditional Acceptance Letter from both INSEAD and Tsinghua University before registering online for the National Entrance Exam in October each year. The actual exam will take place at Tsinghua University in December each year. We encourage interested applicants to submit their applications early to ensure timely registration of the entrance exam.

Application rounds

We operate a rolling admission process, which means that the earlier you apply, the earlier you will get a final decision.

For reference, the application deadlines of each round for the class starting in September 2027 are:



Final Application Deadlines for Chinese Nationals

For administrative processing, Chinese nationals must submit their applications earlier:

- **Mainland China**
Final deadline is **Round 3: 7 October 2026**
- **Hong Kong, Macau, and Taiwan**
Final deadline is **Round 4: 16 December 2026**

Tuition fees

The tuition fees* for the current intake are: **US\$130,625**.
