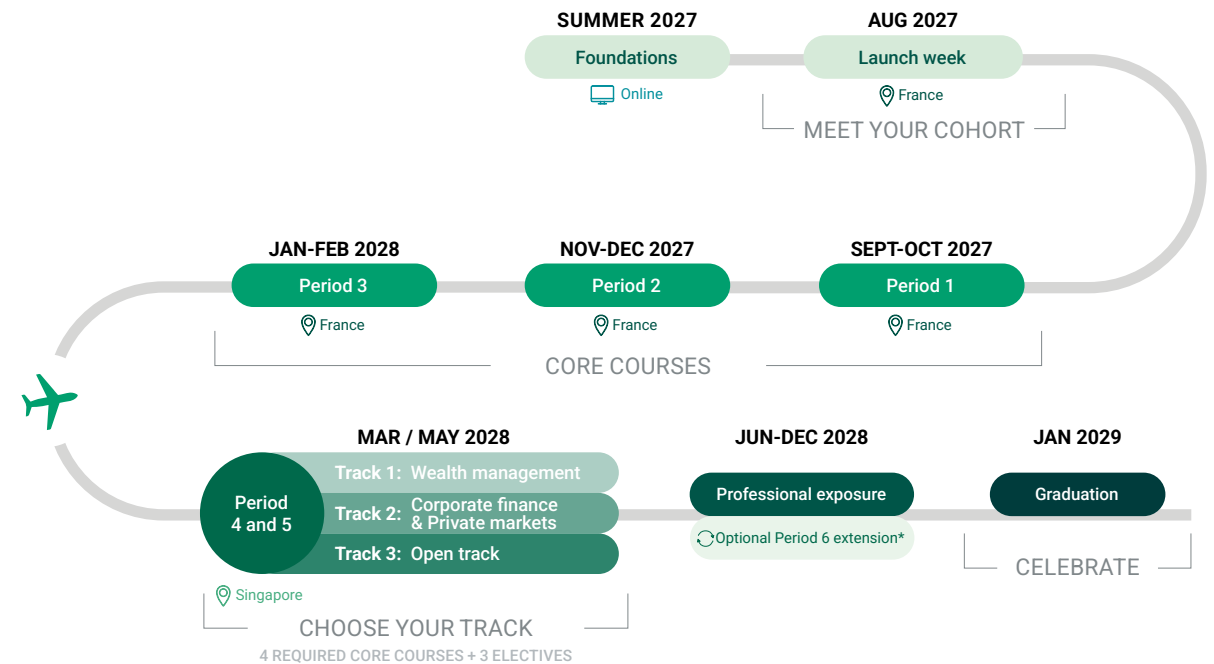

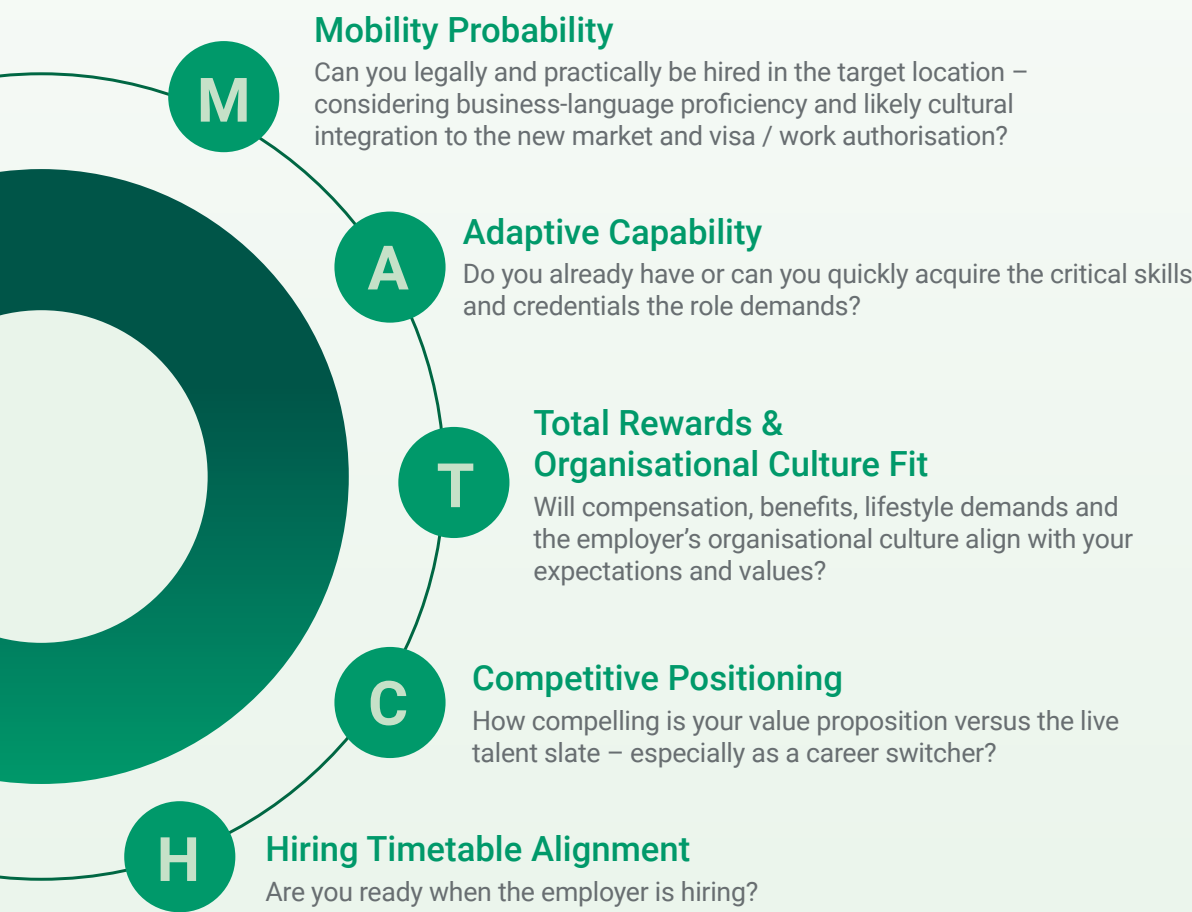
MATCH Framework

Admissions process

All elements of your application will be thoroughly reviewed by the Admissions Team. The selection process is on a rolling basis that will take up to eight weeks from the date you submit your application.



Admissions criteria

We seek bright, motivated individuals with a solid academic foundation, a global outlook and the ability to thrive in a dynamic, multicultural community.

Rolling admissions

Your application will be evaluated as soon as it is complete, including your two recommendation letters, irrespective of when you apply. Final decisions are released at any point of time within eight weeks of you submitting a complete application.
